Proof of successful completion of any teacher education programme in face-to-face mode approved by National Council for Teacher Education (NCTE).

**NOTE:** Those who have successfully completed Diploma in Primary Education (DPE) through IGNOU, approved by NCTE and are considered as trained teacher have to bring the following documents.

- (a) Identity Card (b) Original Marks Sheet of three modules of exams of DPE provided by IGNOU (c) Provisional Certificate of DPE (d) Certificate of six months enrichment programme (e) Service
- book for proof of having trained teacher to whom so ever applicable.

- 4. Caste Certificate (For reserved Category) issued from SDO/DM.
- 5. Certificate of Handicappedness (where applicable).
- 6. Entrance Test Admit card. (Original).
- 7. **2 (Two)** passport size coloured photographs.
- 8. A Bank Draft of **Rs. 45,000**/- as course fee in the form of Bank Draft issued from Nationalized Bank of India namely: **Central Bank of India**/**SBI/PNB/Canara Bank/Bank of India** in favour of **Director**, **DDE**, **M.U.** payable at **BodhGaya**.
- 9. A Demand Draft of **Rs. 3000/-** per year towards supply of Text materials. The DD will be in favour of **Director, DDE,M.U,BodhGaya** payable at **BodhGaya**.
- 10. Rs. **2000**/- in cash towards outsourced purchase of Carry Bag, Assignment Copy (10 nos.), Lesson Plan (2 nos.), Enrolment Slip & Laminated Identity Card.
- 11. Rs. 1000/- in cash towards 'Students Welfare Fund'.
- 12. One self attested photocopy of all the original documents has to be submitted at the time of counselling.

Provisional selection is not the guarantee of admission. If any thing found incorrect/misinformed/without substantive proof/human error, the claim for admission will not be entertained. If the candidate fails to appear on above date, in no case his/her claim for admission will be entertained. It is mandatory to submit an **Affidavit by the NOTARY** that the Certificate marks sheets etc. Submitted by the candidate is correct and genuine. Even one the day of Counselling if it is found that candidate does not fulfill the requisite conditions of admission as per NCTE norms his/her case shall be cancelled immediately.
